

- (II) The Pension Fund Manager, MCBFSL as the outgoing trustee and HMB as the incoming Trustee executed the First Supplemental Trust Deed of Pakistan Islamic Pension Fund ("PIPF") dated June 16, 2011, which was registered with the Sub-Registrar-I, Jamshed Town, Karachi under Registered No. 244 of Book No. IV dated June 16, 2011 and M.F. Roll No. U-44358/7167 of the Photo Registrar Karachi dated June 23, 2011, whereby MCBFSL was retired from the trusteeship of the Fund and HMB was appointed as the Trustee of the Fund and furthermore, the Pension Fund Manager and HMB as the incoming Trustee also amended certain Clauses of the Trust Deed in accordance with Clause 19 of the Trust Deed.
- (III) The Pension Fund Manager has proposed to change the existing Trustee of the Fund vide its letter No. PD/37/08/2013 dated August 13, 2013 and HMB has accepted to be removed from the trusteeship of the Fund vide its letter No. HMB/TO/5231/13 dated December 27, 2013. The Pension Fund Manager served a notice of retirement No. PD/84/03/2014 dated 5th March, 2014. to HMB in accordance with Clause 7.7 of the Trust Deed.
- (IV) CDC has accorded its consent to the Pension Fund Manager for being appointed as Trustee of PIPF in place of HMB vide its letter No. CDC/T&C-SII/DH/270/2013 dated July 10, 2013.
- (V) The Securities & Exchange Commission of Pakistan ("the SECP") has approved the appointment of CDC as the Trustee of PIPF in place of HMB and has further approved the consequent amendments to the Trust Deed, vide its letter No. 9(1) SEC/SCD/PW-AHIL/644 dated 20th May, 2014, annexed hereto as Annexure "A".

The Pension Fund Manager, HMB as the outgoing trustee and CDC as the incoming trustee, ereby agree upon the terms and conditions for the retirement of HMB and the contemporaneous appointment of CDC as the trustee of PIPF on the Effective Date.

PEREFORE THIS SECOND SUPPLEMENTAL TRUST DEED OF PAKISTAN PENSION FUND (PIPF) FOR CHANGE OF TRUSTEE, WITNESSETH AS

Effective Date

The retirement of HMB and the contemporaneous appointment of CDC as the trustee of Pakistan Islamic Pension Fund have taken place within a period of 30 days when this Second Supplemental Trust Deed of Pakistan Islamic Pension Fund for Change of Trustee has been executed by the Pension Fund Manager, HMB and CDC ("the Effective Date").

2. Retirement of HMB and Appointment of CDC as the Trustee.

- 2.1 On the Effective Date mentioned in Clause 1 above, HMB has resigned as and has ceased to be the trustee of the PIPF and CDC has been appointed as the Trustee of the Fund in place of HMB. CDC is deemed to have become a party to the Trust Deed as Trustee in place of HMB and all terms, conditions, responsibilities, obligations, rights and entitlements of the Trustee under the Trust Deed, have become applicable to CDC as the Trustee of the Fund.
- 2.2 From the Effective Date, all references to HMB under the Trust Deed, First Supplemental Trust Deed and the Offering Document shall be deemed to be references to CDC as the Trustee.
- 2.3 On the Effective Date, HMB has handed over to CDC as the new Trustee, all the Trust Property, including assets, securities, instruments and all other properties of Pakistan Islamia Panaian Ford and Islamia Panaian For

Offering Document, the Voluntary Pension System Rules, 2005 (as amended or substitution from time to time) in place of HMB, with each from the Effective Date:

- 2.4 The retirement of HMB and appointment of CDC in its place as the Trustee of the Fund shall be deemed to be contemporaneous to that the continuity of the Trust and its business and operations are maintained without any emption.
- 3. Liabilities and Responsibilities of HMB and CDC
- 3.1 HMB shall continue to be liable for any default in or non-performance of its duties as trustee or for any negligence on its part or on part of its officers or officials, nominees or agents and the provisions of the Trust Deed, the Offering Document, the Voluntary Pension System Rules, 2005, any other applicable laws, circulars, SROs, notifications and court orders (if any). Subsequent to Effective Date, CDC shall be responsible for the same.
- 3.2 HMB shall indemnify the Pension Fund Manager, CDC and PIPF in respect of any default, non performance or violations of the terms and conditions of the Trust Deed, the Offering Circulars, SROs, notifications and court orders (if any) that may have taken place, advertently prior to and up to Effective Date and which may come to the notice of the Pension Fund Manager or the CDC or the SECP at any time after the Effective Date.
- 4. Opening of Bank Accounts
- CDC shall open new Bank Accounts titled "CDC Trustee Pakistan Islamic Pension Fund" for the Pension Fund and each Sub-Fund for, inter alia, (i) receipt of proceeds of Seed Capital Units and subsequent Contributions into the Pension Fund, (ii) credit of proceeds realized on account of any transfer or withdrawal at or before retirement or re-allocation in relation to Individual Pension Accounts, and (iii) withdrawals from Approved Income Payment Plans for the Pension Fund, as required under the Trust Deed and the Offering Document of the Fund and HMB shall forthwith transfer the balances from the existing Bank Accounts to the new Bank Accounts to be opened by CDC, except those Bank Accounts tentioned in Clauses 4.2 and 4.3 hereafter.

Dalli balances in those existing Bank Accounts in which cheques, dividends warrants and other bayment instruments (collectively "the Cheques") may have been drawn or issued by HMB on account of the Trust and have not been realized, shall be retained in the said existing Bank Accounts, but only to the extent of aggregate amounts of such unrealized cheques, for a period of six (6) months from the Effective Date, so that the Cheques already issued by HMB up to the Effective Date can be encashed from such Bank Accounts. After the expiry of six (6) months from the Effective Date, all such Bank Accounts shall be closed and the balances, if any, shall be transferred to the new Bank Accounts opened and maintained by CDC.

- All other Bank Accounts maintained by HMB and existing on the Effective Date (other than those mentioned in Clauses 4.1 and 4.2 above) in which HIVB may have deposited cheques, payment orders and other instruments for collection (collectively "the Collection Cheques") on account of the Fund shall be closed within a period of seven (7) days from the Effective Date or from the date of the realization of all outstanding Collection Cheques that may have been deposited by HIMB on account of the Fund for collection, whichever is later and the credit balances shall be transferred to the new corresponding Bank Accounts to be opened and operated by CDC.
- 4.4 From the Effective Date HMB shall hold the Bank Accounts mentioned in Clauses 4.2 and 4.3 above and the balances therein as an agent for CDC who shall become the Trustee of PIPF on the Effective Date.
