This Second Supplemental Trust Deed of Alhambra Islamic Income Fund (Formerly: MCB Islamic Income Fund) is made and entered into at Karachi, on this 28th day of February, 201

1. **MCB-Arif Habib Savings and Investments Limited**, a listed public limited company incorporated under the Companies Ordinance, 1984 (the "Ordinance"), having its registered office at 24th Floor, Centrepoint, Off Shaheed-e-Millat Expressway, near KPT Interchange, Karachi (hereinafter called the "**Management Company**") which expression where the context so permits shall include its successors in interest and assigns) of the one part:

II. **Central Depository Company of Pakistan Limited**, a public limited company incorporated in Pakistan under the Ordinance, having its registered office at CDC House, 99-B, Block B, SMCHS, Main Shahra-e-Faisal, Karachi (hereinafter called the **"Trustee"** which expression where the context so permits shall include its successors in interest and assigns) of the other part.

A. The Management Company is a Non-Banking Finance Company licensed by the Commission under the Non-Banking Finance Companies (Establishment and Regulation) Rules, 2003, (hereinafter referred to as the "Rules", which expression shall include any amendments thereto) to, inter-alia, carry out asset management services, including investment schemes under trust deeds, and to establish and operate Shariah Compliant unit trusts; (License to undertake asset management services attached hereto as Annexure "A").

- B. The Management Company has been authorized by the Securities and Exchange Commission of Pakistan (the "SECP"/ the "Commission") vide its letter bearing reference No. NBFC/MF-RS/MCBIIIF/2011/48 dated January 25, 2011 attached herewith as Annexure "B" to constitute the Trust under the name and title of "MCB Islamic Income Fund" (hereinafter referred to as "the Scheme", or "the Trust" or "the Unit Trust" or "the Fund" or "MCB IIF") and to register this Trust Deed, pending registration of the Scheme as a Notified Entity under Section 282CA of the Companies Ordinance, 1984 ("the Ordinance") for the establishment and operation of the Scheme in accordance with the provisions of the Non-Banking Finance Companies and Notified Entities Regulations, 2008 (hereinafter referred to as "the Regulations") and this Trust Deed;
- C. MCB Asset Management Company Limited and the Trustee executed a Trust Deed dated March 07, 2011 to constitute MCB Islamic Income Fund ("Unit Trust" or the "Fund" or the "Scheme" or the "MCB IIF"), which Trust Deed was registered with the Sub-Registrar II, Saddar, Karachi, under Registered No.60 of Book No. IV Addl. dated March 07, 2011 and M.F. Roll No. U-19113/6970 dated March 15, 2011 of the Photo Registrar Karachi, (the "Trust Deed");
- D. The Management Company and the Trustee have mutually decided to modify and restate the Trust Deed of the Scheme in line with "Standardized Trust Deed for Mutual Funds" template in accordance with Clause 22.1 of the Trust Deed, vide a First Supplemental Trust Deed of MCB Islamic Income Fund dated May 18, 2015 which was registered with the Sub- Registrar-II, Saddar Town, Karachi, under Registered No. 226 of Book No. IV dated 18-05-2015 and Digital Scanning No. SDII-1815 dated 22-05-2015.
- E. MCB Asset Management Company Limited has been amalgamated with and into the Management Company with effect from June 27, 2011. After this date, the Management Company is acting as the Asset Management Company of MCB IIF;
- F. In accordance with sub-clause 20.2 of the Modified and Restated First Supplemental Trust Deed, the Management Company and the Trustee have agreed to further amend certain Clauses of Modified and Restated Trust Deed of MCB IIF through this Second Supplemental Trust Deed; and
- G. The SECP has approved this Second Supplemental Trust Deed, vide its letter No. SCD/AMCW/MCBAHSIL/MCBIIIF/396/2017 dated January 30, 2017 annexed hereto as Annexure "B".

1. Amendment of Clause 1 of the Trust Deed:

Clause 1 be and is hereby replaced by the following text:

1. Name of the Scheme

Alhamra Islamic Income Fund (Formerly: MCB Islamic Income Fund)

Note: The name of the Fund has been changed from MCB Islamic Income Fund to Alhamra Islamic Income Fund. MCB Islamic Income Fund (the Previous Fund name) appearing anywhere in the Modified and Restated First Supplemental Trust Deed shall be read as Alhamra Islamic Income Fund. The abbreviation of MCB IIF shall also be changed to ALHIF.

2. Amendment of Clause 2 of the Trust Deed:

Clause 2 be and is hereby replaced by the following text:

1. Category, Type and Benchmark of the Scheme

Type: ALHIF is an Open-ended Scheme.

Category: ALHIF is Shariah Compliant (Islamic) Income Scheme.

Benchmark: Six (6) months average deposits rates of ~~Three~~ (3) A-rated Scheduled Islamic Banks or Islamic windows of Conventional Banks as selected by MUFAP.

3. Amendment of Sub clause 25.50 of the Trust Deed:

Sub clause 25.50 be and is hereby replaced by the following text:

25.50 "Trust" or "Unit Trust" or "Fund" or "Alhamra Islamic Income Fund" or "ALHIIF" or "Scheme" means the Unit Trust constituted by Trust Deed as amended and replaced by Modified and Restated First Supplemental Trust Deed and this Second Supplemental Trust Deed for continuous offers for sale of Units of the Trust,

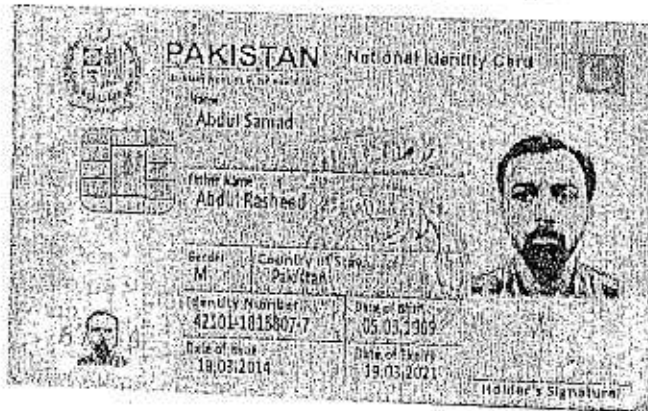
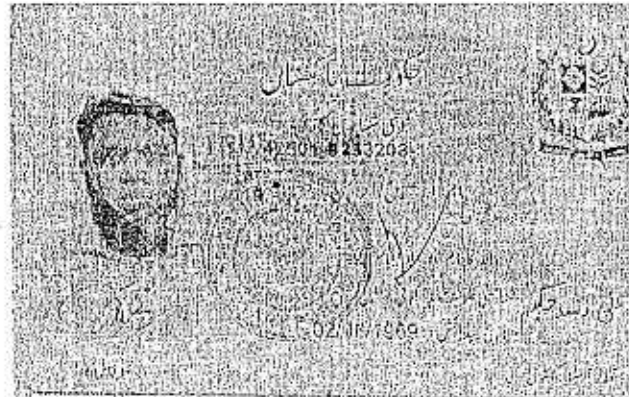
